

1. The Consultants shall be required to submit a bid comprises of a single package containing two (02) separate envelopes. Each envelope shall contain separately the ‘Financial Proposal’ and the ‘Technical Proposal’.
2. The Financial Proposals shall be opened of those Consultants whose technical proposal is considered and approved.
3. The Selection of Consultants shall be made as per Evaluation Criteria method as mentioned in the documents of Request for Proposal.
4. The Consultants shall be required to provide also following documents at the time of Bid submission
 - a. Certificates of registration of a Firm with PEC and PCATP or registration with professional body of country of origin for foreign firm.
 - b. Documents to substantiate the forming of JV/Association as per guidelines of the governing body (PEC/PCATP) if any.
 - c. National Tax Number of consultant(s) & SRB.
 - d. Audited Statements of Accounts and Annual Turnover (200 Millions) for the last three years.
 - e. Details of maximum of 10 similar assignments of developmental works of HEI’s and 10 general works (Building) amounting to Rs. 500 million or more of last 10 years.
 - f. A certificate / affidavit that the firm has not been blacklisted or debarred by any Government / Autonomous / International Body.
5. The incomplete Expression of Interest or received after due date mentioned above will not be considered.


